

Summary of Key Points
Analysis of Exit Destinations by County, Program Type, and Organization
For March 2018

The HMIS admin team completed analysis of client exit destinations from HMIS program discharge records for the month of March 2018 (n = 927). The analysis presents findings by county, over program type, and by org/program.

The summary tables show the total exits by destination category, along with permanent housing exit rates. Analysis also includes the total number of exits with unknown exit destination type along with the corresponding exit rates.

Key findings of the monthly reporting include:

- In aggregate, the PH exit rate for March was 47% with 437 of 927 exits leaving to PH destinations, continuing an increasing trend since July 2017 (33%).
- Of the 437 PH exits, Emergency Shelter programs exited 121 clients to PH (28%) and Transitional Housing programs exited 68 clients to PH (16%).
- Street Outreach and Emergency Shelter project types should not be evaluated solely on exits to PH. Often, placements into institutional settings, transitional shelters, or residential projects are positive outcomes for these project types.
- March PH rates descending by county were Oahu (50%), Maui (47%), Hawaii (40%), and Kauai (14%).
- Homeless Prevention and Rapid Re-Housing projects had the highest PH exit rates (88% and 80% respectively) due to the inherent nature of these programs, however, one would expect that these rates be closer to 100%.
- The number of clients with unknown exit data continued to trend downward with 171 clients in March 2018. The missing exit data rate was 18%; the missing exit data rate first calculated in July 2017 was 34%.
- Hawaii and Oahu had the greatest proportion of exits to unknown locations in March, with 22% (29 exits) for Hawaii and 19% (110 exits) for Oahu. Usually ES or Outreach projects represent the vast majority of these exits.
- Hawaii Emergency Shelter (44%) and Oahu Homeless Outreach programs (44%) had the highest rates of missing exits in March.

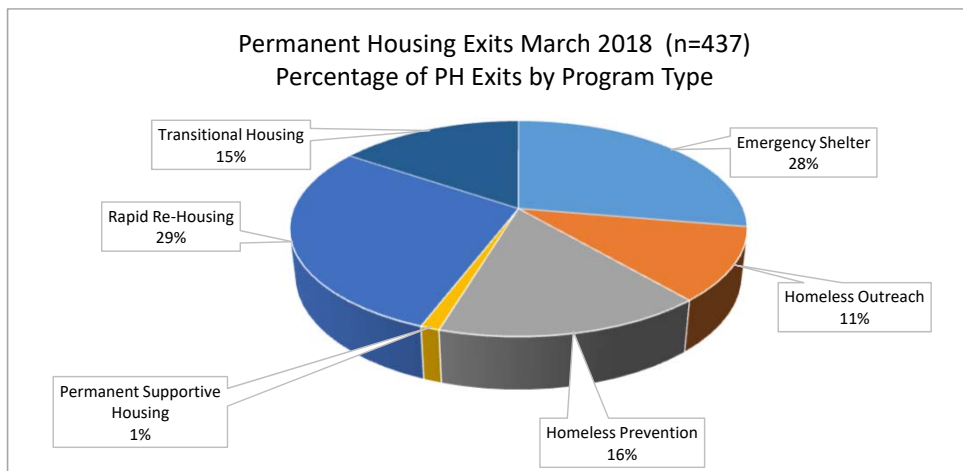
