Analysis of Exit Destinations by County, Program Type, and Organization

For September 2018

The HMIS admin team completed analysis of client exit destinations from HMIS program discharge records for the month of September 2018 (n = 1,067). The analysis presents findings by county, over program type, and by org/program.

The summary tables show the total exits by destination category, along with permanent housing exit rates. Analysis also includes the total number of exits with unknown exit destination type along with the corresponding exit rates.

Key findings of the monthly reporting include:

- In aggregate, the PH exit rate for September was 54% with 575 of 1,067 exits leaving to PH destinations, representing an increase compared to August (48%) and a similar rate compared to July (53%); overall a marked improvement compared to September 2017 (33%).
- Of the 575 PH exits, Homeless Prevention programs exited 141 clients to PH (25%), Emergency Shelter programs exited 137 clients each to PH (24%), Transitional facilities exited 108 clients to PH (19%) and Rapid Re-Housing exited 105 clients to PH (18%).
- Street Outreach and Emergency Shelter project types should not be evaluated solely on exits to PH. Often, placements into institutional settings, transitional shelters, or residential projects are positive outcomes for these project types and the clients within.
- September PH rates descending by county were Hawaii (67%), Oahu (57%), Kauai (39%), and Maui (37%).
- Homeless Prevention and Rapid Re-Housing projects had the highest PH exit rates (98% and 77% respectively). Due to the inherent nature of these programs, however, one would expect that these rates be near 100%.
- The missing exit data rate decreased in September 2018 to 14% (154 clients with unknown exits), an improvement compared to August's 22% missing data rate. June 2018 had the lowest rate to date (12%). The missing exit rate first calculated in September 2017 was 34%. Oahu represented 71% of the missing total for Sep 2018.
- Oahu and Maui had the greatest proportion of exits to unknown locations in September, with 15% (110 of 719 exits) for Oahu, and 22% (42 of 194 exits) for Maui. ES and Outreach projects accounted for the majority of these exits.
- Oahu Street Outreach (30%) and Emergency Shelter (25%), and Maui Emergency Shelter (29%) had the highest rates of missing exit data in September.

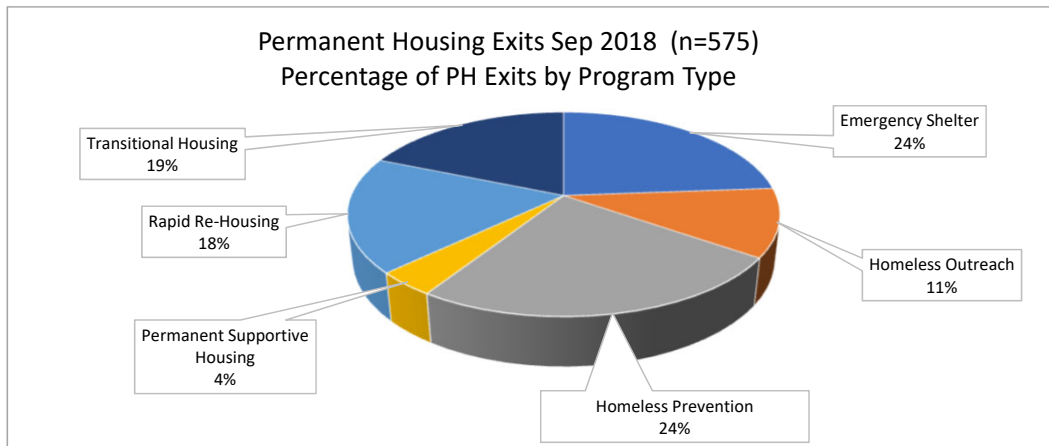
