Re: November 2019 HMIS Monitoring Reports (Neighbor Islands – Bridging the Gap)

Attached for your review and dissemination to Continuum agencies is the November 2019 HMIS monitoring report. Below are brief highlights from the attached reports.

1. End of month, November 2019 Census summary by Continuum and Statewide (pp. 2-5)
 - The Neighbor Island census for emergency shelter (ES) and transitional housing (TH) programs decreased in November 2019 (653), compared to October 2019 (667), with an increase in ES and a decrease in TH programs.
 - The total “vacant beds” compared to the HIC bed capacity was 224 (ES and TH) and 173(permanent supportive housing – PSH). This is a decrease compared to last month. HIC openings can also vary depending on differences in household size.
 - 26 programs on the Neighbor Islands had utilization rates of less than 85% or greater than 110%. These programs are marked in red.
 - Active outreach clients totaled 394, a slight decrease compared to October 2019 (398 clients).
2. Consent report for November 2019 (pp. 6-12)
 - VI-SPDAT Assessments: Consent to share data rate for Neighbor Islands was 96%, a two-percentage point increase compared to October.
 - By Name List: Consent to share data rates as of the 12/09/19, BNL cut was 98% for the CoC. November rates included: 100% for Kauai singles; 99% for Maui families and singles and Hawaii singles; 90% for Kauai Families, and 86% for Hawaii Families.
 - For adult program intakes entered in November 2019 (n=275), the Neighbor Islands consent to share data rate was 97%, two percentage points higher than in October 2019.
 - One program had a consent rate below 80% (November Intakes) - highlighted in RED.
3. Length of stay (LOS) by agency and program for clients exiting during November 2019 (pp. 13-15)
 - The average LOS over all programs was 109 days (representing 332 exits), a decrease compared to October 2019 (138 days).
 - The average LOS for Neighbors Islands in November (109 days) was significantly less than the statewide average LOS for all months from January through August 2019, which ranged from 143 days in July to 244 days in March 2019.
 - Excluding PSH, the average LOS was 106 days. ES and street outreach programs’ LOS were the shortest (74 and 94 days). PSH and RRH programs’ lengths of stay were the longest (325 and 169 days).
 - By County, Hawaii (133 days) averaged the longest LOS, followed by Maui (92 days) and Kauai (89 days).
 - Emergency shelter average LOS ranged from 65 days on Maui to 102 days on Kauai.
 - Transitional housing average LOS ranged from 101 days on Hawaii to 197 days on Kauai.
4. Timeliness (entries and exits) during November 2019 (pp. 16-17)
 - Intake timeliness was 2.71 average days, a decrease compared to 2.81 average days in October.
 - 20 programs (highlighted in RED) averaged more than 3 days to enter intakes.
 - Exit timeliness decreased to 1.5 average days, a decrease compared to 2.14 average days in October.
 - 13 programs (highlighted in RED) averaged more than 3 days to enter exits.

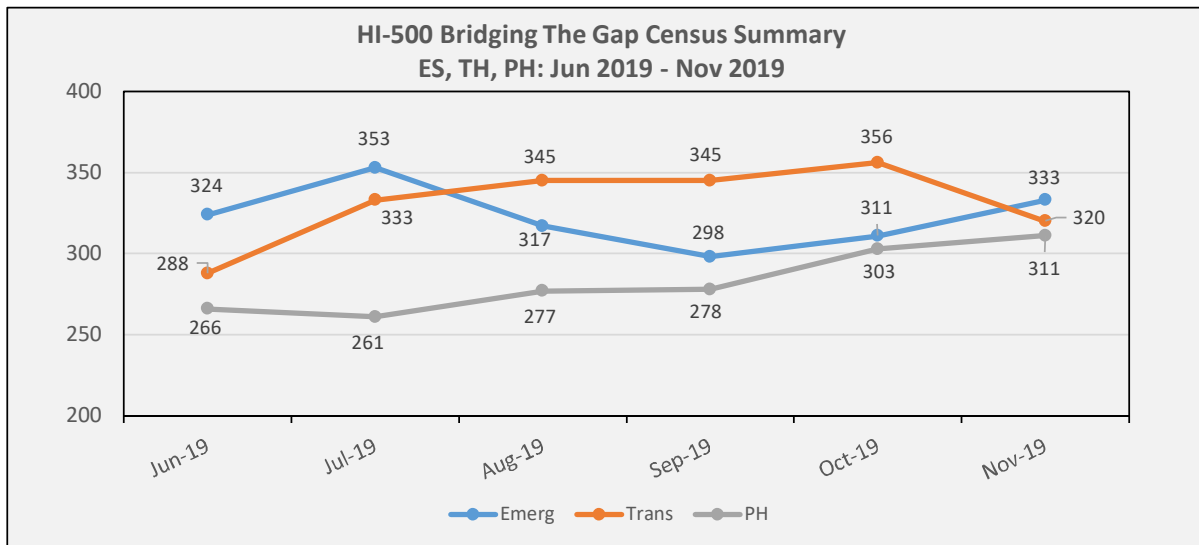

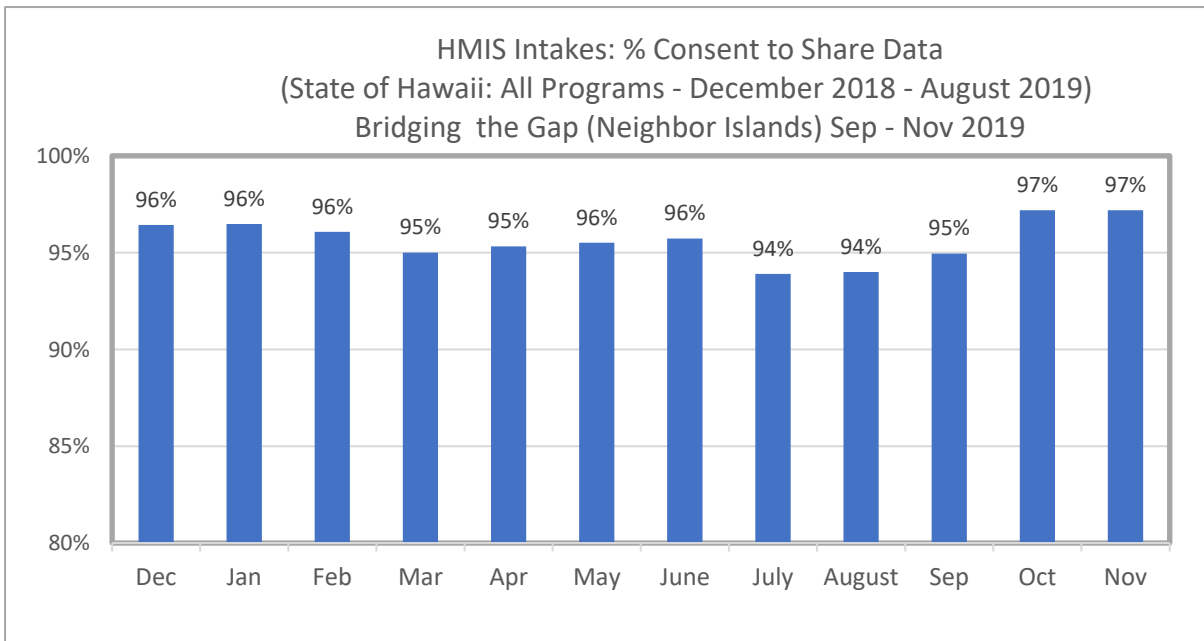
